Course Description:

Through a variety of learning and/or shop/lab learning and assessment activities, student in this course will: identify safety and personal health hazards according to OSHA guidelines and the "Right to Know" law; determine the different types of substrates and sanding materials relevant to auto body surface preparation; identify the process to clean and prepare a substrate for paint; distinguish between the properties, uses and manufacturer specifications of metal treatments and primers; distinguish among the various types of spray guns and equipment; explore various paint codes and specifications for use; identify the various paint systems; explore the types of paint defects; distinguish between damage and non-damage related corrosion; and identify final detail procedures.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Use shop safety equipment according to protocol.
- 2. Demonstrate proper substrate preparation for refinishing.
- 3. Select appropriate type of undercoating.
- 4. Use cleaning procedures necessary for refinishing preparation.
- 5. Protect surface areas to remain unpainted.
- 6. Apply procedures for mixing, catalyzing and activating paint.
- 7. Apply paint to a auto body using variety of spray techniques.
- 8. Demonstrate appropriate high volume and low pressure spray gun operation.
- 9. Correct the cause and defect in an auto body paint job.
- 10. Apply color, sanding and buffing techniques to correct surface defects.
