**Course Description:**

This course teaches advanced concepts of drafting communication as it pertains to mechanical engineering and processes of manufacturing. Subjects include line types, orthographic projections, sectioning, language, auxiliary views, pictorial drawings, and scale usage.

**Course Competencies:**

Upon completion of the course, the student should be able to:

1. Use advanced drawing media and related drafting materials.
2. Apply correct annotation to drawing, line styles and weights, dimensioning and title blocks.
3. Create and place appropriate drafting views.
4. Convert 2D and 3D drafting and models to CNC code using conversion software.
5. Apply tooling practices for machining.
6. Convert a 3D scan to a CAD/Parametric model.

**Course Content:**

- A. Work with equipment related to CNC applications
- B. Project based designs related to field of study
- C. Collaborate to solve design problems
- D. Practice standards and properly detail a working project for conveying a design solution
- E. Apply safety-shop-machine-tool
- F. Apply metrology skills
- G. Demonstrate CNC Machining Skills and 3D printing
- H. Demonstrate an understanding of machinable materials
- I. Demonstrate the ability to convert a 3D scan to 3D model

**Learning Assessments:**

Competencies may be evaluated by multiple measures, including exams, papers, article reviews, research, experiments, and projects.
