Course Description:

This database application course is designed to show students how to create, store, sort, and retrieve data. The course will also cover Microsoft Windows concepts and terminology.

- 4. Understand and develop table relationships

- 7. Modify design views in forms, reports, queries, and tables
- 8. Create and print multi-view reports
- 9. Create queries, forms, and reports using automated wizard
- 10. Understand how to manually create queries, forms, and reports
