Course Description:

This course covers refrigeration theory, operation, testing, and repair of air conditioning systems. The use of refrigerant recovery methods will also be discussed.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Test AC system for refrigerant leaks.
- 2. Perform a diagnosis of AC system malfunctions.
- 3. Recover refrigerant from the AC system.
- 4. Purge an AC System.
- 5. Flush an AC System.
- 6. Check compressor oil level.
- 7. Evacuate the AC system.
- 8. Perform a full recharge of an AC system.
- 9. Check recycled refrigerant stored in portable containers.
- 10. Determine the proper refrigerant and prevent cross-contamination.
