Course Description:

This course covers the fundamentals of Spanish pronunciation, vocabulary building, conjugation of the present tense, and introduction of two past tenses. The course will provide practice in understanding and speaking simple phrases, elementary reading and writing, and some study of the culture of people in countries where Spanish is spoken.

Course Competencies:

The learning outcomes and competencies detailed in this syllabus meet or exceed the learning outcomes and competencies specified by the Kansas Core Outcomes Groups for this course as approved by the Kansas Board of Regents. (Kansas Regents Shared Number Course and Title: **KRSN Course SPA 1010 Spanish I.**)

Upon completion of the course, the student should be able to:

1. Pronounce Spanish words correctly with appropriate intonation.
2. Use simple Spanish sentence structures in speaking and writing.
3. Use and understand common Spanish greetings, farewells, and expressions of courtesy.
4. Use the Spanish words for numbers from 0-100,000.
5. Express the time, dates, and weather in Spanish.
6. Make appropriate use of the present tense of regular verbs in Spanish.
7. Use Spanish nouns, articles, subject pronouns, descriptive adjectives, and possessive adjectives.
8. Create compound sentences in Spanish.
9. Use Spanish linguistic construction in compound verbs.
10. Use Spanish descriptions, adjectives, and adverbs.
11. Compare aspects of Spanish-speaking cultures with his or her own culture.

- 2. Conversation and Composition
 - a. Basic speaking practice daily
 - b. Basic sentence writing

Learning Assessments:

Students will be assessed by use of written and verbal exercises, translation work, and assessments, along with completion of Spanish compositions.
