Course Description:

This course is designed to provide experience related to the skills and knowledge acquired in the Medical Assisting field by allowing students to apply classroom and lab knowledge in real medical arenas.

- 3. Record patient information accurately
- 4. Follow HIPAA guidelines for patient care
- 5. Follow OSHA Safety Guidelines
- 6. Demonstrate professionalism in any given situation
- 7. Adapt to various clinical settings

Course Content:

In this course, clinical sites are used to evaluate students learning and give them needed experience before graduation.

Guidelines for Requesting Accommodations Based on Documented Disability or Medical Condition
