Course Description:

This course provides an introduction to the principles of pharmacology. Emphasis is placed on nursing care related to the safe calculation and administration of medications to clients across the life span.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Discuss the principles of pharmacology, pharmacokinetics, and pharmacodynamics in relation to medication therapy.
- 2. Discuss nursing implications and concepts of safety when performing medication administration.
- 3. Demonstrate proper techniques that support safe medication administration.
- 4. Describe the legal and ethical implications/aspects of medication administration.

Course Content:

- A. Principles of Pharmacology
 - 1. Describe the role of the United States Food and Drug Administration in determining the safety of drugs for use by the population.
 - 2. Define common terminology, abbreviations, and symbols used in describing drug properties.
 - 3. Describe common terminology used for medication administration.
 - 4. Differentiate between the terms pharmacology, pharmacokinetics, and pharmacodynamics.
 - 5. Identify measures that support safe medication administration.
 - 6. Define the following terms: drug actions, side effects, adverse effects, nursing implications, contraindications, and interactions.
 - 7. Describe the various resources that support evidence-based drug information.
 - 8. Discuss legal/ethical issues related to medication administration.
- B. Safe Medication Administration
 - 1. Discuss factors that can decrease the risk of making a medication error.
 - 2. Identify the rights of medication administration.
 - 3. Determine the various routes by which medication can be administered.
 - 4. Perform basic metric conversions and drug calculations.
 - 5. Discuss the role of the nurse related to educating clients about their medications.
 - 6. Demonstrate proper techniques that support safe medication administration (oral, ophthalmic, otic, nasal, rectal, topical, inhaled, vaginal, subcutaneous, intramuscular, and intradermal medications)
- C. Clinical Lab Objectives:
 - 1. Apply the rights of medication administration.

- 2. Perform basic metric conversions and drug calculations
- 3. Demonstrate proper techniques that support safe medication administration:
 - Oral
 - Ophthalmic
 - Otic
 - Nasal
 - Rectal
 - Topical
 - Inhaled
 - Vaginal
 - Subcutaneous
 - Intramuscular
 - Intradermal medications
